

The area called "CAORLE BAU BEACH" is a portion of the beach, specially equipped and limited, made available to guests accompanied by pets, whose use is subject to compliance with the conditions set out below.

This regulation is drawn up on the basis of the following current regulations:

- Regional Law of 23 February 2016, n. 7 Regional Stability Law 2016, Amendments to Article 18 bis of the Regional Law of 28 December 1993, n. 60 Protection of pets and prevention of stray dogs.
- Ordinance 3 March 2009 Ministry of Labor of Health and Social Policies. Article 1, paragraphs 1, 2, 3 and 4 - contingent and urgent ordinance concerning the protection of public safety of the aggression of dogs (G.U. No. 68 of 23.03.2009).
- Municipal ordinance in force.

## **ACCESS and USE**

Access to the area is limited to the opening hours of the beaches as per the BATHING SECURITY ORDER in force below.

This access is allowed, exclusively, to those in possession of a regular receipt issued by the beach staff or by the coupon "Bau Beach" (properly completed and signed) issued by the structures affiliated by Consorzio Arenili Caorle as well as all the requirements listed below.

This tax document, together with those indicated below, pertaining to the sanitary conditions of the accompanying animal, must be handed over to the facility manager for checking the validity, which will also proceed to request verification of the existence of the additional requirements required.

The lack of documentation and the above requirements will allow the personnel in charge, at its sole discretion, to prohibit access to the area.

It is forbidden to take the animals outside the equipped area, identified and bounded by the existing fence and accessible through the marked route, and the water mirror in front of the plant, indicated by buoys.

## **EQUIPMENT**

Guests are provided the standard beach equipment consisting of a parasol and two sun loungers, remaining the same burden, for the welfare of their animals, provide a suitable placement in the shade.

A watering bowl is also provided and a shower is available for the exclusive use of animals.

Finally, the consortium makes available to the users bags and headstock through a distributor or by the beach staff.

In order to maintain the health and hygiene of the Bau Beach beach, the Consortium will guarantee periodic cleaning and rehabilitation of the area.

## **REQUIREMENTS**

In order to access and use the services of Bau Beach all pets must comply with all the rules of hygiene, including vaccinations, required by current legislation and in particular:

- Dogs must be identified by means of a microchip or a tattoo and provided with a valid health card;
- rabies vaccination is compulsory for dogs, ferrets and cats coming from abroad and in any case carried out for at least 21 days.
- Access to the area is forbidden to dogs with aggressive syndrome and to females in heat.
- the dog leader must always bring with him the documents attesting the periodic vaccination prophylaxis against the main infectious diseases (distemper, leptospirosis, and parvovirus), prophylaxis against the main infectious diseases and parasites
- it is forbidden to bring dogs suffering from cardiovascular diseases to the beach

## **BEHAVIOR TO ADOPT**

The management of the dog inside the Bau beach must take place by means of a leash of maximum length equal to 1,50 meters which must be kept even when stationed, in addition the dogs must be equipped with a muzzle which must be used in case risk to the safety of persons or animals or at the request of the competent authority

The dog must be fitted with an anti-parasitic collar or an equivalent parasitic device.

Each solid dejection must be promptly removed and immediately deposited in the containers designated for the purpose

Liquid dejections must be promptly dispersed by diluting them with abundant sea water.

It is obligatory for dog owners to avoid, as far as possible, prolonged barking and excessively lively behavior of their dogs; otherwise, the concessionaire in the person of the personnel in charge may decide, at its sole discretion, the expulsion, without the possibility of any exception by the owner who commits himself and obliges to respect the judgment

The dog must always be under the control of the owner so that it is not allowed that the same remain unattended or free to roam.

Bathing is allowed only in the area delimited by buoys, of five dogs at most simultaneously in the presence of the conductor in the water and at the end of the bath the dog must be reassured on a leash.

## **RESPONSIBILITY**
